# **Construction of dwelling**

# at Garage Between Lower and Higher Woodfield Road, Torquay

the application received 4 June 2008 and the plans and particulars submitted for the following reason(s):

- O1. The application site forms part of an extensive green wedge that forms an appropriate and important setting to Lisburne Crescent a Grade II Listed Terrace. The erosion of this through the construction of a dwelling would be damaging to the architectural character and quality of the Listed Terrace and to the wider conservation area. As such, the proposal would be contrary to Policies H9, H10, BES, BE1, BE5 and BE6 of the saved adopted Torbay Local Plan 1995-2011.
- 02. The loss of existing car parking opportunities would exacerbate local car parking difficulties and highway safety difficulties contrary to Policy T25 of the saved adopted Torbay Local Plan 1995-2011.
